Judge Holthus was elected to the Eighth Judicial District Court in Department 18 in 2018. I am running to retain my seat as a trial judge. I have been an attorney in Clark County for over 30 years. For two years, I was a civil litigation attorney. For 27 years, I was a trial lawyer in the DA's office. I did approximately 150 jury trials, and spent 16 years on the Special Victim's Unit prosecuting sexual assault, child abuse and domestic violence cases. In court nearly every day, I have handled thousands of cases — from misdemeanors to murders. Since being elected judge, I handle a split docket of criminal/civil calendars, handling all types of criminal and civil matters, and I have had several jury and bench trials. I am a career public servant. For 30 years, my only client has been justice.

 HERNDON
 FOR SUPREME COURT**

Creator and Chief Judge of the court's Murder Case Team 2017-present. Chief Judge - Criminal Division 2009-2017.

A top ranked Judge for 15 years and received the highest performance rating of any District Court Judge in 2019. Maintained in office by the people of Nevada through three elections in 2006, 2008 and 2014.

Appointed to the bench by Governor Kenny Guinn in 2005 after a 14 year career in the District Attorney's Office, the last 9 of which were spent as the Head of the Special Victim's Unit, leading the prosecution of crimes involving the physical and sexual abuse, and murder, of women and children.



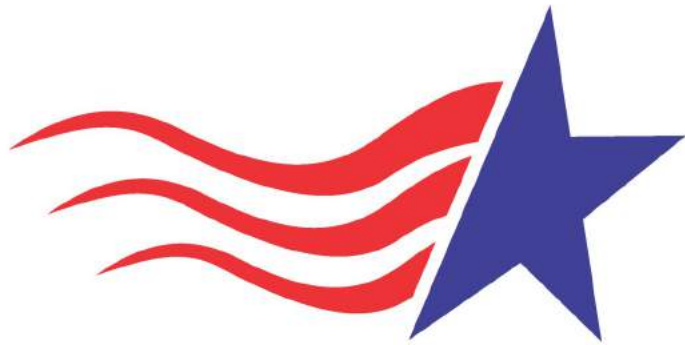
